“The Center for International Affairs was founded in 1958 and was renamed the Weatherhead Center for International Affairs in 1998 in gratitude for the magnificent endowment established by Albert and Celia Weatherhead and the Weatherhead Foundation. The Center was created as a means of confronting the world's condition, a condition diagnosed by Robert Bowie and Henry Kissinger in their gripping *The Program of the Center for International Affairs* (1958).”

The Weatherhead Center also has a Fellows Program. “The Fellows Program is the principal forum for the interaction of practitioners with the faculty, students, and visiting scholars of the Weatherhead Center. The program was inaugurated in 1958, simultaneously with the establishment of the Center itself, in the belief that the Center's research activities would benefit from the contributions of nonacademic professionals with broad practical experience in international affairs, and that the Center could broaden the practitioners' horizons and deepen their understanding of the contemporary issues in which they are professionally involved.”
